



Consent to Body Piercing
Release and Waiver of All Claims

I hereby acknowledge by signing this agreement that I have been given the full opportunity to ask any and all questions I might have about obtaining a tattoo from Irish Ink Tattoo Co and that all of my questions have been answered to my full and total satisfaction. I specifically acknowledge by my initials that I have been advised and agree to all the facts and matters set forth below:

- I acknowledge that I am not under the influence of drugs and/ or alcohol, and/ or any intoxicating substance at this time of the body piercing.
I am not a hemophiliac. I am not pregnant. I do not have diabetes, epilepsy, hepatitis, HIV/AIDS, or any communicable disease or infection. I do not have any physical, mental, or medical conditions, which may affect my well-being as a direct or indirect result of my decision to have any body piercing related work done.
I understand that the Marion County Health Department does not allow body piercing on skin surfaces with sun burn, rash, pimples, infections, open lesions, moles, or skin that manifest evidence of unhealthy conditions.
I acknowledge that it is not reasonably possible for the artist or any representative of Irish Ink Tattoo and Piercing to determine whether I might have an allergic reaction to any materials used in the process of the body piercing: during or after the procedure, and I agree to accept the risk that such reaction is possible.
I acknowledge that an infection is always possible, particularly in the event that I do not take proper care of my body piercing. I also agree to follow all instructions concerning the care of my own body piercing while it is healing, and have been given oral instructions on the aftercare of my body piercing.
I acknowledge that in the event I wish to remove the body piercing jewelry that scarring may or may not remain after the area is healed.
I acknowledge that I have truthfully represented to Irish Ink Tattoo and Piercing or any representative that I am eighteen (18) years or older and that the following information is true and correct.
I acknowledge that the obtaining of my body piercing is my choice alone. I consent to the application of the body piercing, and to any actions or conducts reasonably necessary to perform the body piercing procedure.
I hereby give my artist and/ or Irish Ink Tattoo and Piercing permission to copyright and/ or use and/ or publish photographic portraits or pictures of me or in which I may be included in whole or in part of reproduction thereof made through any media for advertising, or any of the lawful purpose whatsoever. I waive any right I may have to inspect and/ or approve the finished product or the use which may be applied.
I agree to release and forever discharge hold harmless Irish Ink Tattoo and Piercing or any representative or subcontractor, from any and all claim, damages, or legal actions arising from or connected in any way with my body piercing or the procedure and/ or conduct used in the application of my body piercing.
